**Resolution:** Finance Committee decided that the Construction works as approved by the Building Committee of Tripura University dated 04/07/2016 will be undertaken only subject to the condition that the project are fully funded and sufficient fund are available within the University to undertake the project within XII plan budget allocation and that no liabilities on this accounts will be passed to the coming year.
