As per the official records, Shri Bhanu Lodh was engaged as OSD (Finance) in Tripura University vide appointment letter No. dated 11.12.2018 purely on contract basis for a period of 1 (one) year on a monthly remuneration (last Salary drawn, Rs 1,11,960 – pension, Rs 2703) i.e., Rs. 1,09,257/- per month. Shri Lodh was engaged in Tripura University purely on contractual basis w.e.f. 01.01.2019 to 30.11.2019.

Shri Bhanu Lodh has approached the Hon'ble High Court of Tripura for re-fixation of his monthly remuneration as per the pay revision by his previous employer, i.e. Tripura Jute Mill Ltd. (A Public Sector Undertaking), Govt. of Tripura vide order dated 05.11.2019.

Accordingly, his prayer for re-fixation of his monthly remuneration (last drawn salary pension) as per the revised pay of his previous employer including his claims for leave encashment and half pay leave were not accepted as he was purely engaged on contractual basis in Tripura University. The Ministry of Education, Department of Higher Education, Govt. of India vide its letter dated 03.07.2023 has also given its views and directed the University to follow the guidelines of Ministry of Finance, Department of Expenditure, Govt. of India, vide OM dated 9th December, 2020 on the matter.
