ORDER

Subject: Financial assistance (2nd installment) to the Department of Botany, Tripura University, Suryamaninagar-799130 (Tripura) on FIST Program.

In continuation of this Department's sanction order of even number dated.17.08.2012, sanction of the President is hereby accorded for the revision of the project cost from Rs.32.50 lakh to Rs.33,30,699/- with additional support of Rs.80,699/- for an additional Equipment-**Thermostat**. The break-up of the revised total cost would be 'Equipment'-Rs. 20,30,699/-, Infrastructure-Rs. 5.0 L, Networking and Computational Facility-Rs. 5.0 lakh and 'Maintenance'- Rs.3.0 lakh.

2. Sanction of the President is also accorded to the payment of **Rs. 6,00,000/- (Rupees Six lakh only)** along with carry forward of unspent balance of Rs. 65,736/- + Interest Rs. 80,699/- available with the Department to the **Registrar, Tripura University, Suryamaninagar-799130 (Tripura)** under FIST Program as 2nd installment of the grant for creation of Capital Assets in 2016-2017 for E- Rs. 1,46,462/- (Thermostat), IF-Rs. 1.0 L for Books and NW-Rs. 5.0 L (set up a computer lab with 8 nos. PCs, 1 Server, Multipurpose Printer, Scanner, Computer tables & Chair (8 nos.) and networking peripherals).

3. Sanction of the President is also accorded to carry forward of unspent balance of Rs.1,46,462/- (Rupees One lakh forty six thousand four hundred and sixty two only) from the previous year to this current financial year 2016-2017 for its utilization.
