ADMISSION NOTIFICATION for PhD under "AICTE Doctoral Fellowship" (ADF) Scheme



The Proforma for application is available with this advertisement in the university website. The minimum eligibility as per ADF norms shall be as in <https://www.aicte-india.org/schemes/students-development-schemes/ADF-Scheme> :

- The candidate should have qualified Valid GATE Score/ NET-JRF/NET Qualified during the last 5 years.
- The candidate must have secured the minimum percentage of educational qualification prescribed for eligibility as in Under Graduate and Post Graduate be 70% (69.5 % and above) for General/OBC candidates. In the absence of percentage, the candidate must have secured minimum cumulative grade point average (CGPA) of 7.5 on the scale of 10 or equivalent at Bachelors and Masters.
- **Reservations as per Govt. of India norms.**
- The candidate should be less than 30 years of age as on date of admission.

Filling up of online forms shall be done from the University website <http://admission.tripurauniv.in/>:

- During online registration, an applicant will be asked to provide an e-mail id and a mobile number, and the login details will be sent to the provided e-mail id or the given mobile number via SMS, and in future all correspondences in this regard will be made to this e-mail id and the given mobile no. via SMS.
- It is recommended that the applicants change their password on the first log in, if they so wish.
- After successful login, applicant may fill their Application Form for the ADF programme.

The short-listed candidates will be informed via email accordingly. All guidelines of AICTE Doctoral Fellowship as well as Tripura University norms need to be followed.
