

Report of the Committee on Preparation of Reservation Registers

The Tripura University vide their order No. TU/REG/Reservation/1/2015 dated 26.09.2022 constituted a Committee with the following constitution to finalize the roster /reservation registers for both teaching and non-teaching posts of the University:

1. Shri K. G. Verma, Former Joint Secretary, DOPT, Government of India- Chairman
2. Shri Shreenibas Chandra Prusty, Registrar, Indian Law Institute, New Delhi- Member
3. Dr. K. B. Jamatia, Joint Registrar, Tripura University - Member Secretary

2. The Committee met on 28<sup>th</sup>, 29<sup>th</sup> & 30<sup>th</sup> September, 2022 and found that the University has by and large, prepared Reservation Registers and Reservation Roster Registers in respect of teaching posts as well as non-teaching posts as per DoPT guidelines. The Committee, however, suggested that the University should use proforma for preparing the Reservation Registers as prescribed by the Department of Personnel & Training in the Brochure on Reservation in Services for SCs, STs and OBCs issued vide their OM No 36011/1/2011- Estt (Res) dated 17<sup>th</sup> November 2011. Entries in the Registers in respect of EWS may be made in the light of instructions on EWS reservation.

3. The Brochure provides that if an organization feels that Reservation Register has become unwieldy or otherwise, may start the Register afresh by following the procedure of initial preparation of Register. The brochure has given the method of initial preparation of Registers as follows:

“In order to prepare the reservation, register initially, names of all the candidates holding the post as on the date of starting the reservation register may be entered in the register starting with the earliest appointee who was in the cadre as on the date of start of register. If an appointee in the cadre is a Scheduled Caste candidate, SC may be entered in column 4 of the register against his name. If that candidate was appointed by reservation, SC may be written in column 5 also but if he was appointed on his own merit, UR will be written in column 5. If the next appointee is a general category candidate, general shall be written in column 4 against his name and UR in column 5, and so on till all the appointments are adjusted. After making entries as indicated above, details about the number of SC, ST and OBC candidates appointed by reservation, backlog reserved vacancies, if any, may be indicated in ‘Remarks’ column.”

4. The Committee accordingly prepared the Reservation Registers afresh for the cadres of Assistant Professor, Associate Professor and Professor as on 1<sup>st</sup> October, 2022 on the basis of information provided by the University. Registers so prepared are attached as Annexure 1, Annexure 2 and Annexure 3 respectively.

5. It is observed from the Reservation Registers for the post of Assistant Professor prepared as on 1<sup>st</sup> October 2022 that the cadre of Assistant Professor has a strength of 178 posts of which 122 are filled. As such there are 56 vacancies in the cadre of which 2 are backlog reserved vacancies for SCs. For earmarking vacancies as reserved or unreserved, the following table may be used. While earmarking reservation, efforts are to be made to complete the shortfall of SCs, STs and OBCs subject to the condition that total number of vacancies earmarked reserved out of the current vacancies is not more than 50% of the current vacancies. Limit of 50% does not apply to backlog vacancies. As such backlog vacancies are to be earmarked reserved for respective categories. 10% of the current vacancies may be earmarked reserved for EWS.

6. The cadre of Associate Professor has a strength of 75 posts of which 26 are filled. As such there are 49 vacancies in the cadre of which 12 are backlog vacancies. 8 for SCs and 4 for STs. For earmarking vacancies as reserved or unreserved, the following table may be used:

7. The cadre of Professor has a strength of 49 posts of which 3 are filled. As such there are 46 vacancies in the cadre of which 9 are backlog vacancies, 6 for SCs and 3 for STs. For earmarking vacancies as reserved or unreserved, the following table may be used:

8. The Committee suggests that while earmarking vacancies as reserved or unreserved in different departments, efforts may be made to distribute reservation evenly in all the departments, as far as possible. The Committee did an exercise to distribute reservation as per tables attached as Annexure 4, Annexure 5 and Annexure 6. The Committee suggests that University authorities may go through the distributions suggested above and make necessary changes as required.

9. As already pointed out, the University has prepared Registers/Reservation Roster Register for Non-teaching posts as per DoPT guidelines. However, entries in the remarks column in








Roster Registers may be made as per the guidelines contained in para 5.10 of the brochure which provides as follows:

“Roster registers shall be maintained for cadres with 2 to 13 posts. For preparing roster, names of all the incumbents in the cadre as on 2.7.1997 may be entered in the register starting from the earliest appointee. If an appointee in the cadre is a Scheduled Caste candidate, SC may be entered in column 5 of the register against his name. If that candidate was appointed by reservation, SC may be written in column 6 also but if he was appointed on his own merit, UR will be written in column 6. If the next appointee is a general category candidate, general shall be written in column 5 against his name and UR in column 6, and so on till all appointments are adjusted. In doing so, a general category candidate may appear on a reserved point and an SC/ST/OBC candidate may appear against an unreserved point. If name of an SC/ST/OBC candidate appointed by reservation is entered against a general point, entries may be made in remarks column against that point and also against nearest point reserved for SCs/STs/OBCs, as the case may be, to the effect that such a candidate is to be treated to have been adjusted against the relevant reserved point. Likewise, entries will be made in remarks column for candidates who are appointed as general category candidates but whose names appear against reserved points. Similar adjustments will be made in respect of SC candidates appearing against a point reserved for STs or OBCs and so on. After all the 14 points are consumed, fresh cycle of the roster may be started. As many roster points may be treated to have been consumed on the date of start of the roster register as many employees occupy the roster points as on the date of start of the register. From that point onward, vacancies may be filled as per roster points subject to adjustment of reserved category candidates appointed by reservation and general category candidates as explained above.”
