Greetings from Tata Consultancy Services! Hope this mail finds you in good health and spirit!

At the onset allow us to extend our heartfelt gratitude towards you and your entire team for enabling the recruitment process of students from the batch of 2021. Your support has hugely contributed towards our rapid increase in headcount, which currently stands at over five hundred thousand employees across the globe.

We are excited to announce our plan for **Ninja Hiring** this year, for students from the batch of 2022 from the **Tripura University**. You would be happy to learn that the registration for the students have started in our NextStep Portal and would be open till August 15, 2021. Please find all the details as below –

- **Mode of Test**

For Ninja Hiring, this year, candidates may choose to take the test in either the **Remote Proctored** mode, wherein they can take the test from the comfort of their home; or **In-Center** mode, wherein they have to visit the nearest TCS iON Center to take the test.

Please note –

- Mode of Test once selected, **cannot be modified**. Candidates must be careful of their selection.
- In-Center test locations have limited number of seats, which would be available on a **first-come-first-serve** basis.

- **Test Date**

Test starts **August 30, 2021 onwards**. Candidates will be communicated individually of their allotted date and slot by TCS iON, shortly before the test.

- **Registration Timeline**

Registration window will be open **from July 15, 2021** for a month, **till August 15, 2021**.

- **Application Process**

This year, our Ninja Test Process will be administered as part of the National Qualifier Test (NQT) conducted by TCS iON, our Official Test Partner.

- Candidates need to register on TCS Next Step Portal. The link to register is – <https://www.tcs.com/careers/TCSNinjaHiringYoP2022>

- Upon clicking the link, the students would be guided to our Ninja Hiring Page. This page contains all the necessary information regarding the drive, like, Test Eligibility, Test pattern, FAQs etc.
- Upon reading the details properly, candidates must click on 'Registration Open' which would redirect them to our NextStep Portal.
- Candidates must click on 'Register Now' and register themselves for 'IT' and not BPS. Candidates may use their previous account by logging in as well if the data provided by them is accurate.
- A one-page form would come up next, which they must mandatorily fill up to generate their TCS Reference ID, i.e., their CT / DT Reference ID and create an account for themselves.
- Candidates must then login with their Reference ID and password and click on 'Application Form'. They must fill up the detailed form carefully and upload their latest resume and a recent passport size formal picture.
- Upon submission, candidates would be prompted to the 'Apply for Drive' screen, which they must mandatorily click on and choose their preferred test mode and submit.
- **In the Track Application menu, the status should be updated as 'Applied for Drive' on or before August 15, 2021.**

- **Eligibility Criteria**

There is no change in the Ninja hiring Eligibility Criteria from the yesteryears.

- **Percentage:** Minimum **aggregate marks of 60% or CGPA of 6.00** in each of Std. X, Std. XII, Diploma (if applicable), Graduation and Post-Graduation examination. A candidate must consider all the subjects present in the mark sheet to arrive at the aggregate score.
- **Backlogs / Arrears / ATKT:** The student should not be having more than **1 active backlog / arrear / ATKT** at the time of appearing for the TCS Selection process in the highest qualification. If selected, NO pending Backlog or Arrear will be permitted at the time of joining TCS
- **Gap / Break in Education:** It is mandatory to declare gaps in education if any. Break in education should not be due to extended education (examinations cleared after the time stipulated by the Board / University). Any break in education **should not exceed 24 months** and is permissible only for valid reasons. Relevant document proof, as applicable, will be checked for gaps in education
- **Course Types: Only Full-Time courses** will be considered (Part Time / Correspondence courses will not be considered). Students who have completed their Secondary and / or Senior Secondary course from NIOS (National Institute of Open Schooling) are also eligible to apply if the other courses are full time. All pending backlogs should be completed within the stipulated time duration
- **Work Experience:** Students with prior work experience of **up to 2 years are eligible** to apply for the TCS Ninja Hiring Process.
- **Age:** A student should be of **18 to 28 years** of age to participate in the TCS Ninja Hiring process
- **Courses & Discipline:** Students from the batch of 2022, pursuing B.E. / B.Tech. / M.E. / M.Tech. / MCA / M.Sc. from any specialization offered by the institute may apply.

- **Super Ninja – TCS Digital Process**

Toppers of the test would be given a chance for the TCS Digital selection process.
