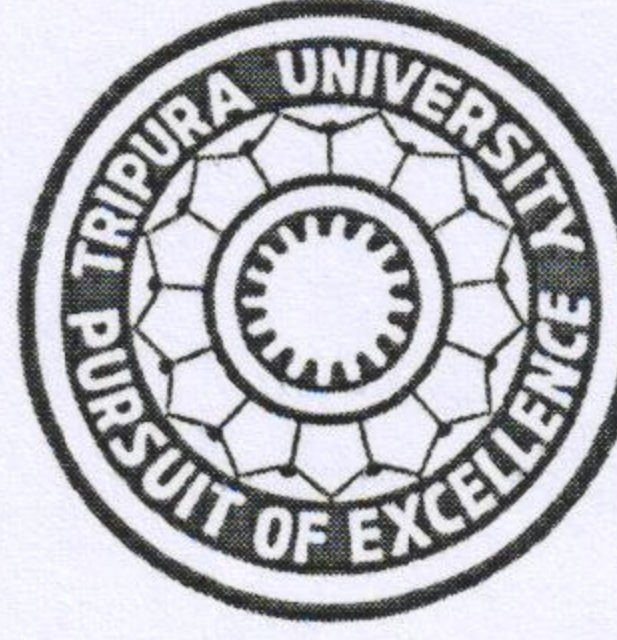



## NOTIFICATION

In compliance with the MHRD communication vide D.O. No.Secy (HE)/MHRD/2020, dated 21.03.2020 and letter issued by the Secretary, UGC, New Delhi vide F.No.1-14/2020 (website), dated 21<sup>st</sup> March, 2020, this is hereby notified that –

1. All offices under Tripura University shall remain closed till 31<sup>st</sup> March, 2020 except the following essential services:  
(i) Medical, (ii) Security, (iii) Electricity, (iv) Water Supply.  
The controlling officers of the above mentioned services are directed to draw up a roster of staff who are required to render essential services during this period.
2. All non-teaching staff are permitted and advised to work from home till 31<sup>st</sup> March, 2020 and should be available on telephone and electronic means of communication at all times. They should attend office, if called for, in case of any exigency.
3. All faculty members, researchers are permitted and advised to work from home till 31<sup>st</sup> March, 2020. They should be available on telephone and electronic means of communication at all times. They should attend office, if called for, in case of any emergency.
4. The offices of Vice-Chancellor, Registrar, Controller of Examinations, Librarian and Finance Officer will remain open. However, officers and staff may be alternatively rotated as per requirement of the concerned Head of the Branches.
5. Teachers, officers and staff are advised not to move out of their respective station with a view to contain and prevent the spread of COVID-19.
6. Visitors shall not be allowed to enter the University premises without prior permission of the University authority.
7. This notification shall be reviewed as per further directives of the UGC/Central Government/State Government.
