NOTIFICATION

Resolution of the Dean's Committee regarding Programme-specific Eligibility Criteria for M.A. in Education and M.A. in Philosophy

Academic Session 2026–27

The attention of all concerned is invited to the decision of the Dean's Committee, Tripura University, on the following agenda item:

“To consider the proposal for amendment of the programme specific eligibility criteria for admission to the M.A. in Education and M.A. in Philosophy programme for the Academic Year 2026–27.”

After consideration of the proposal, the Dean's Committee recommended the amendment of the programme-specific eligibility criteria for admission to the M.A. in Education programme for the Academic Year 2027-28 as follows:

Eligibility Criteria recommended for M.A. in Education

Candidates seeking admission to the M.A. in Education programme shall fulfil any one of the following eligibility requirements:

Passed B.A. (Honours/Pass) in Education with a minimum of 50% marks for General category candidates and 45% marks for SC/ST/OBC (NCL) candidates; or

Passed B.Ed. with a minimum of 50% marks for General category candidates and 45% marks for SC/ST/OBC (NCL) candidates; or

Appeared/appearing in the final examination of B.A. (Honours/Pass) in Education or B.Ed.

The Dean's Committee further resolved that the above matter be placed before the Academic Council for approval.

Eligibility Criteria recommended for M.A. in Philosophy

With regard to the proposal for amendment of the programme-specific eligibility criteria for admission to the M.A. in Philosophy programme, the Dean's Committee did not recommend the proposed amendment. Accordingly, the eligibility criteria for M.A. in Philosophy shall remain as notified in the Tripura University e-Prospectus 2026–27, until any subsequent amendment is duly approved by the competent statutory authority.

All concerned Departments/Admission Committees are therefore advised to follow the eligibility criteria currently approved and notified by the University while processing admissions, until further orders.
