On behalf of Tripura University, Sealed Quotations from manufacturers/authorized dealers or bonafide suppliers of repute are invited for supply of the following equipment's for a DST-WTC Project sponsored by Department of Science & Technology (DST), Government of India. The quotations complete in all respect must be sent or submit to Prof. Shaon Ray Chaudhuri, Principal Investigator, DST-WTC Project, Department of Microbiology, Tripura University, West Tripura, PIN - 799 022 on or before 26th June, 2024 during office hours.

Specification

The unit should be fitted with pressure gauge upto 20 psi. with spring loaded safety valve for pressure adjustment and a dead weight safety valve with system capacity of total load of 21 ltr


It is hydraulically tested upto 40 psi and is supplied with electrical fittings, cord and plug to on 220 / 230 volts A.C. supply.

It should have a size with diameter and height in mm: 12' x 12'

Supplied complete with tripod stand.

Terms and Conditions:

1. The supply order will be awarded to the vendor based on the merit of the quotation and a suitable procedure adopted by TRIPURA UNIVERSITY. The procedure to be adopted for evaluating the quotations shall be final and binding on all the parties.
2. Rates quoted should be on F.O.R. Tripura University at the working site on DOOR DELIVERY BASIS and include costs of installation if any
3. Delivery: Delivery of goods at Tripura University, Suryamaninagar, will have to be maximum within 60 (Sixty) days from the date of receipt of Purchase Order. If a firm fails to deliver the goods within the stipulated time, it must inform the reasons of delay. The purchaser reserves the right to cancel the



order in absence of sufficient reasons for delay beyond four weeks after expiry of initial 60 days

4. **Payment:** 90% payment shall be paid against delivery, installation and satisfactory performance of all items and balance 10% payment will be made maximum within 60 days (sixty) days from the date of successful installation and acceptance of ordered goods by a duly constituted. Payment shall be made through NEFT/RTGS within the country. In case of foreign consignor payment shall be made through LC/TT.
5. **ANNUAL MAINTENANCE CONTRACE (AMC) Rates,** after the expiry of the warranty period are to be clearly specified failure to which the quotation will not be considered for evaluation.

7. **Currency:** QUOTATIONS ARE TO BE IN INDIAN RUPEES for goods manufactures in India. Goods of foreign origin are to be supplied by a foreign agency and may be quoted in USD/ Sterling/ Euro/ Yen depending on the source of origin and subject to acceptance of terms of payment by an Indian bank
8. **WARRANTY:** Vendors should undertake to provide the Purchaser 2 years unconditioned and unlimited, free maintenance service (which will include repair and maintenance of all kits or parts, and supply of spare parts as and when required for smooth functioning of the system) from the date of installation. The system supplied should carry 2 years on site / comprehensive warranty from the date of installation. Date of installation of the ordered equipment will be decided by the Purchaser.
9. **The Registration Number of the Firm along with the GST No.** allotted by the Authorities, as well as PAN number of the firm allotted by the Income Tax authorities should be submitted, failing which vendor's bid would become invalid and same shall be rejected.
10. Tripura University does not bind itself to purchase any / all the quantity and to accept the lowest quotation and reserves to itself the right to increase or decrease the quantity.
11. Tripura University reserves the right to choose, accept or reject any or all requests / offers, in full or part at any stage, reduce or increase the quantity without assigning any reason thereof. The quantity / number shown in the document is only indicative. Tripura University will not be responsible for any postal losses or delay in submission of documents. The quotation documents are non-transferable.
12. Suppliers / Vendors are free to visit Tripura University Campus, if feel so, to submit their offers.
13. All disputes arising in connection with executing the Purchase Order will be subject to the Jurisdiction of the Courts in Agartala only.
