### General Terms & Condition

- 1. **Scope of Work:** Scope of work covered under this includes supply, transportation and installation at the Department of Chemistry, Tripura University Suryamaninagar;
- **2. Qualifying requirements:** The bidder must either be a manufacturer or authorised dealer having credential of supplying and installation of above-mentioned items.
- 3. An amount Rs.1,000.00 (non-refundable cost of tender fee) in the form of Demand Draft in favour of Finance Officer, Tripura University on State Bank of India payable at Tripura University Campus Branch. Photocopy of the same is to be uploaded along with the tender documents and original DD may be deposited to Tripura University through post or by hand in the office of the Finance Officer on or before of submission of Technical Bid.
- 4. EMD: An amount Rs.10,000.00 (Refundable) in the form of Demand Draft in favour of Finance Officer, Tripura University on State Bank of India payable at Tripura University Campus Branch. (Those who have who has participated in the 1st call of Notice Inviting e-Tender vide No. F.TU/FIN/Chemistry/07/Vol-III/20 dated 06-01-2025 need not to submit afresh). However, Photocopy of the earlier EMD is to be uploaded along with the tender documents and original DD may be deposited to Tripura University through post or by hand in the office of the Finance Officer on or before of submission of Technical Bid.
- **5. Warranty**: Instrument must have minimum 01-year standard warranty.
- **6.
