General Terms & Condition

1. **Scope of Work:** Scope of work covered under this includes supply, transportation and installation at the Department of Microbiology, Tripura University Suryamaninagar;
2. **Qualifying requirements:** The bidder must either be a manufacturer or authorised dealer having credential of supplying and installation of above-mentioned items.
3. **An amount Rs.1,000.00 (non-refundable cost of tender fee) in the form of Demand Draft in favour of Finance Officer, Tripura University on State Bank of India payable at Tripura University Campus Branch. Photocopy of the same is to be uploaded along with the tender documents and original DD may be deposited to Tripura University through post or by hand in the office of the Finance Officer on or before of submission of Technical Bid.**
4. **EMD: An amount Rs.10,000.00 (Refundable) in the form of Demand Draft in favour of Finance Officer, Tripura University on State Bank of India payable at Tripura University Campus Branch. (Those who have participated in the 1st call of Notice Inviting e-Tender vide No. No. F.TU/ FIN/ Microbiology/ 276/ Vol-III/ 18 dated 07-01-2025 need not to submit afresh). However, Photocopy of the earlier EMD is to be uploaded along with the tender documents and original DD may be deposited to Tripura University through post or by hand in the office of the Finance Officer on or before of submission of Technical Bid.**
5. **Photocopy of the same is to be uploaded along with the tender documents and original DD may be deposited to Tripura University through post or by hand in the office of the Finance Officer on or before of submission of Technical Bid.**
6. **Warranty:** Instrument must have minimum 02-year standard warranty.

- 10. Payment Terms:** 95% Payment will be made after satisfactory completion of delivery, 5 % of invoice value will be retained as performance guarantee, and the same will be released after 02 (Two) year from the date of delivery and installation.
- 11.** The contract shall be governed by the Laws and Procedures established by the Government of India and subject to exclusive jurisdiction of competent Court and Forum in Agartala only.
- 12.** Payment will be made strictly through RTGS/NEFT/Bank Transfer.
