The sealed cover envelop with necessary documents must reach to the **Office of the Finance Officer, Tripura University on or before 02-06-2025 upto 5.00 PM**. Sealed cover of the envelop should be marked on the top "**Rate Contract Proposals for Chemicals, Plasticware & Glassware for the Financial Year 2025-2026**".

TERMS AND CONDITIONS

1. Rate Contract Proposals will be accepted as per requirement and desire of Tripura University. Therefore, submission of any/all Rate Contract does not ensure its acceptance.
2. The Rate Contract (if accepted) will remain valid **upto 31-03-2026**, and any order placed on or before the expiry date will be applicable for this rate Contract.
3. The manufacture(s) may declare its Authorised Dealers/Agents for the Financial Year 2025-2026 to place orders and supply of items as per its convenience. The respective dealer/agent has to supply the items for the said Financial Year.
4. The firm/company should be the manufacturer/reputed suppliers/ authorized distributor. (copy should be submitted)
5. **The firm/company must have submitted relevant purchase order issued by Tripura University for Laboratory items, Chemicals, Reagents, Glassware and Plasticware during last 2 years.**
6. A copy of the pricelist must be submitted along with the proposal.
7. The Contract does not ensure for placing of purchase order and procurement of said items. Therefore, the University does not bind itself to the items solely based on this Contract.
8. Purchase Order will be placed as per requirement of Tripura University.
9. Delivery shall have to be done within 20(Twenty) days from the date of issue of Purchase Order.
10. Payment will be made after successful delivery.
11. GST will be paid extra.
12. Prices will be on F.O.R. destination basis.
13. Tripura University reserves exclusive rights to cancel this rate Contract (if necessary) at any point of time without showing reason thereof.
14. All disputes arising in connection with executing this Notification and Purchase Order will be subject to the Jurisdiction of the Courts in Agartala only.
