1. Scope of Work:

The auditor shall review the existence and effectiveness of internal control system(s) and report on the adequacy of those controls.

The key objective of the Internal Audit is to ensure the following at Tripura University:

- orderly and efficient conduct of Institute's working,
- the transactions and decisions taken by the authorized persons reflect the highest
- sense of propriety and governance,
- adherence to Institute's policies,
- the safeguarding of its assets,
- the prevention and detection of fraud and errors,
- the accuracy and completeness of the accounting records and statutory compliances,
- the timely preparation of reliable financial statement.

Detailed scope of audit shall be shared at the time of engagement.

The Internal Audit Report shall be submitted on quarterly basis within one month from the end of respective quarter. However, for the year 2025-26, the report of first two quarters must be completed by December 2025.

2. Eligibility Criteria:-

The interested Firms shall have to comply the following to participate in the EOI process:-

a) The bidder firm must be a Chartered Accountants (CA) Firm recognized by the ICAI (Institute of Chartered Accountants of India)

- b) The bidder firm must be registered with the Institute of Chartered Accountants of India for not less than 5 years as on 31st March 2025.
- c) The bidder firm should have their registered head office in Agartala.
- d) The Firm must be having at least three partners.
- e) The Firm must be having experience in conducting Statutory Audit / Internal Audit of Financial organization/ PSU with annual turnover exceeding Rs.200 crore or Central/State Autonomous Bodies with Annual Budget exceeding Rs. 50 crores as on 31st March 2025.
- f) The Firm is required to submit the Satisfactory Work Completion Certificate/ Documentary Proofs.
- g) The firm must be registered under the Goods & Services Tax Act
- h) The CA firm should have valid PAN and GST number
- i) The CA firm should provide the man power strength of qualified, semi-qualified and audit assisting staff available with the firm.
- j) The firm/partner has not been debarred/blacklisted by any Bank / State Govt/ Central Govt./ State PSU / CPSU / SEBI/ Public Utility as on date.
- k) There should be no legal suit / criminal case pending or contemplated against the CA firm on the ground of moral turpitude or for violation of any law in force.
- 3. PRE-BID Meeting: A meeting of all qualified Bidders will be held on in the Meeting Room of Finance Branch, Tripura University, Suryamaninagar, Agartala for discussion on the scope of work, clarifications, if any. The date and time will be communicated in time.
- 4. Bidder must drop the EoI in the EoI Box available in the Purchase Section, Tripura University (Ground Floor), Suryamaninagar-799022 in the prescribed format (Annexure-I) on or before 14th November 2025 up to 3.00 pm. The Bidders will be short listed after the meeting with qualified bidders. The financial bid will be invited after shorting of the bidders.
