General Terms & Condition

1. **Scope of Work:** Scope of work covered under this includes Supply, installation, Testing and commissioning of Air Conditions Machines at various Departments/ offices within the Tripura University Campus and buy back value of old AC machines (Indoor/ outdoor) if any will be deducted from the original contract/ supply order value;
2. **Qualifying requirements:**
 - A. The tenderer shall submit valid enlistment with the State PWD or Central PWD for Electrical/Electro-Mechanical and AC Works, issued in his/her own name by the competent authority of the State or Central Government.
 - B. The tenderers should submit the Trade License from the AMC, Agartala/other State/Central Electricity Board/organization for Electrical/Electro-Mechanical/AC machines Works in his/her own name issued by the competent authority of state/central Governments.
 - C. The tenderers should submit the labour license in his/her own name issued by the competent authority of labour department of State/Central Govt. for engagement of labourers or any other order regarding exemption of labour license for engagement of labourers by the competent authority of Govt. of Tripura/Govt. of India.
 - D. The tenderers should submit up to date GST clearance certificate in his/her own name issued by the competent authority of Govt. of Tripura/Govt. of India.

- 5. Warranty:** 12 Months countable from the date of successful delivery and installation
- 6. Non-fulfilment of any of the criteria in Technical Bid, the bidder shall not be considered in the price bid and the same will be summarily rejected.**
- 7.** The bidder must have GST Registration No., Trade License, etc.
- 8. Forfeiture of EMD:** The Earnest Money is liable to be forfeited in the event of (a) withdrawal of offer during the validity period of the offer, (b) non-acceptance of orders when placed, or (c) Non confirmation of acceptance of orders within the stipulated time after placement of offer, (d) Any unilateral revision made by the bidder during the validity period of the offer.
- 9. Rate:** The bidder should quote the rate in Indian Currency i.e. INR and such rates are FOR destination basis i.e. at the site of Tripura University, Suryamaninagar-799022. Bidders are required to quote their rate exclusive of taxes, Government Taxes will be paid as per prevailing Government rules at the time of payment.
- 10. Time for Completion:** Delivery and installation of the items must be completed within 30 (Thirty) days from the date of issue of purchase order.
- 11. Payment Terms:** 95% Payment will be made after satisfactory completion of delivery and installation, 5 % of invoice value will be retained as performance guarantee, and the same will be released after 01 (one) years from the date of delivery and installation. The successful bidder should be submitted 5% of invoice value as Performance Bank Guarantee during the warranty period.
- 12.** The contract shall be governed by the Laws and Procedures established by the Government of India and subject to exclusive jurisdiction of competent Court and Forum in Agartala only.
- 13.** Payment will be made strictly through RTGS/NEFT/Bank Transfer.
