Dear Professor Saha,

This is in continuation to this office letter No.F.24-3/2008(CU) dated 5th December, 2008 about the intimation of XI Plan allocation of your University. I am grateful to you for the cooperation extended for furnishing the information required by the UGC.

Based on the priorities indicated by you, as well as the availability of funds from Govt. of India, UGC has approved the final XI Plan allocation of Rs.10000.00 lakhs under General Development Grant. However, the release of grant would be subject to availability of funds received from Govt. of India.

The XI plan allocation under General Development Grant for your University along with the detailed breakup is given in the enclosed statement duly signed by the undersigned. A copy of the Visiting Committee Report has already been given to you in the meeting held in the UGC Office.

The UGC has already finalized the guidelines for the schemes to be operated in the XI Plan. These guidelines are posted on the UGC website www.ugc.ac.in. I would request you to browse the UGC website regularly to keep yourself abreast of the latest XI Plan guidelines finalized by the UGC.

The University may follow the procedure for constructions of buildings strictly as prescribed in the UGC guidelines. The Building Committees should be constituted strictly as per UGC guidelines and the constitution of the Committee should be intimated to UGC.

The University may follow strictly the Government of India/UGC's guidelines regarding implementation of the reservation policy (both vertical (for SCs, STs & OBCs) and horizontal (for persons with disability etc.)) in teaching and non-teaching posts.

The teaching posts as approved by the UGC in the existing departments may be filled up in a phased manner as per requirement of the University. The teaching posts for the new proposed departments may be filled up on the basis of intake of students admitted in the University. The requirement of non-teaching staff will be considered separately by the Committee constituted for this purpose and will be communicated to you shortly.

I hope the university must have also initiated the Academic Reforms as already circulated by the UGC vide its D.O.No.F.1-2/2008 (XI Plan) dated 31st January, 2008. It may also be ensured that the university has adopted the University Grants Commission (Minimum Standards and Procedure for award of M.Phil./Ph.D. Degree), Regulations, 2008.

In the end, I would request you to ensure that the utilization of the grants received by the university shall be submitted to the UGC in time to enable smooth management of funds and to avoid unnecessary audit objections.

2. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants recognition/permission to Tripura University, Plot No- 4415, 4519, VIII- Agartala, PO - Suryamaninagar, Tehsil/Taluka- Suryamaninagar, Town/City- Agartala, Dist- West Tripura, Tripura- 799022 for conducting 4 yr B.A. B.Sc. B.Ed. Integrated (Addl. Course) of four years duration with an intake 50 (one basic unit) from the academic session 2016-2017 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.





At the onset of the meeting, Prof. Anjan Kumar Ghosh, Vice-Chancellor and Chairman of the Academic Council welcomed all the members to the nineteenth meeting of the Academic Council. Prof. R.N. Dutta Purkayastha, Head, Department of Chemistry and Prof. Ashes Gupta, Head, Department of English were then felicitated with flower bouquet for their nomination as member of the Academic Council.

Before proceeding to the day's business Prof. Anjan Kumar Ghosh, Vice-Chancellor and Chairman of the Academic Council gave a brief presentation on the important achievements of the University during the year 2015-16 including the increasing number of publications of research papers and books and organisation of /participation in national/ international seminars/conferences etc., by the faculties of the University. He, in particular, mentioned the receipt of the award and a memento given to the University by the All India Rubber Industries Association Education Trust (AIRIA-ET) for being the first University in the Country to start B.Voc course in Rubber Technology and signing of MoU with the Rubber Skill Development Council (RSDC).

He also reported that two patent applications have been filed, one from the Department of Microbiology and the other from the Department of Human Physiology, and that the Department of


