Resolved that action taken by the Vice-Chancellor of placing Dr. Shankar Nath Tiwari, Assistant Professor, Department of Sanskrit, Tripura University under suspension and passing an order for initiation of disciplinary proceedings against the allegation of sexual harassment be approved.

However, the Executive Council opined that disciplinary proceedings be continued independent of the said recommendation of the ICC as the Internal Complaints Committee (ICC) was constituted with the then Head of the Department of Political Science, Tripura University, which is not in conformity with the provision 4(3) of the University Grants Commission (Prevention, prohibition and redressal of sexual harassment of women employees educational institutions) in higher and students Regulations, 2015, which inter alia says "Persons in senior administrative positions in the HEI such as Vice-Chancellor, Pro Vice-Chancellors, Rectors, Registrar, Deans, Heads of Departments, etc., shall not be members of the ICCs in order to ensure autonomy of their functioning".
