Proceedings of the 29th Meeting of the Executive Council held in Tripura University on 14th November, 2017 at 11:00 A.M.

Prof. Anjan Kumar Ghosh, Hon'ble Vice-Chancellor, Tripura University welcomed all the members present in the 29th meeting of the Executive Council. Thereafter, agenda items were taken up serially one by one and the following resolutions were adopted.

To confirm the proceedings of the 28th Meeting of the Agenda 01/29/2017 Executive Council held on 20th September, 2017. Confirmed with the inputs from M.K. Singh (attached). To report the action taken on the Proceedings of the 28th Agenda 02/29/2017 Meeting of the Executive Council held on 20th September, 2017. Noted with the following points: a) Under agenda 03/28/2017, the report of Fact Finding Committee was accepted. b) Under agenda 12/28/2017 (ii), in view of points raised by two EC members, the Grouping Committee will look into the issue. To consider the proceedings of the 24th Meeting of the Finance Agenda 03/29/2017 Committee held on 10th November, 2017 (*The following matter has been noted for consideration:* (a) Audited Annual Accounts for the financial year 2016-17 (b) To form a committee to invest various funds of the University specially GPF subscription etc. to Banks/ Financial *Institutions*)

To consider the proceedings of the Urgent Meeting of the IQAC, T.U., held on 2nd November, 2017 (Proceedings circulated herewith)

EC resolution:

The word "urgent meeting" be dropped from the proceedings and shall be read as "26th meeting".

Note: Particular attention is drawn to the following agenda keeping in note the Verdict of the Hon'ble High Court of Tripura and resolution adopted thereto in the meeting of the IQAC, as mentioned below:

Agenda No.4: In order to recruit the applicants who obtained their qualification through Distance mode to any Post of Teacher, Officer or any other Staff to the University, the Norms of Supreme Court and UGC will be followed.

EC resolution:

Cut-off date be fixed in consultation with the lawyer to consider the degrees obtained through Distance Education (Off Campus Mode), but not beyond 2005.

Agenda No.5: It is resolved that for recruitment of faculty (Open Posts) or Grade A non-Teaching Posts in the University the minimum qualifying marks should be 50% in Selection Committee. The qualifying marks will be the average of the marks given by all members of the selection committee.

EC resolution:

Accepted. For Group-A Non Teaching posts, minimum 50% marks be fixed as qualifying marks in the interview, as well as in written test (if written test is conducted) along with the relevant DoPT Guidelines. The 50% marks shall be the average of marks provided by all the members of the selection committee.

The same is accepted for teaching positions (direct/contractual) along with relevant UGC Guidelines.

Agenda No.6: For promotion through CAS for various teaching posts the minimum marks obtained should be 50% in the Selection Committee. This is as per the Gazette of India, September 18, 2010 (Bhadra 27, 1932), Page Number 7885; Para 6.2.0.

EC resolution:

Tripura University held on 20th September, 2017 at Kolkata published on 16.10.2017. Sir.

I have gone through the proceedings of 28th meeting of the Executive Council held on 20.09.2017 at Kolkata and found many deviations in reporting of minutes with regards to matters discussed in 28th meeting of the Executive Council of Tripura University dated 20.10.2017. The facts are given below.

1.Agenda 01/28/2017 :

The resolution should be as "Resolved that the proceedings of the 27th meeting of the Executive Council with added notes from two members of Executive Council (Dr. V.K. Karan and Prof. M.K. Singh) be confirmed with the resolution as stated under:" in place of "Resolved that the proceedings of the 27th meeting of the Executive Council be confirmed with the resolution as stated under:"

2.Agendua 03/28/2017:

In this connection, the Executive Council had not empowered Hon'ble Vice-Chancellor to initiate any measures for controlling internal discipline but it was left on the power vested to the Vice-Chancellor to do needful. It was further decided to allow to work the Fact Finding Committee constituted by the authority of the University and out come of the committee would be placed in next E.C.meeting for further action. The resolution adopted here is not in true spirit of decision taken in the E.C. meeting. So, resolution may be modified as under: "In this connection, Vice-Chancellor can take measures to maintain internal discipline using his own power and in this particular case, it was further decided to allow to work the Fact Finding Committee constituted by the authority of the University and out come of the committee would be placed in next E.C. meeting for further action."

3.Agenda 10/28/2017:

At S.No. 6, the appointment was conditional and the condition has not been mentioned in remark column or any foot note has not been mentioned for the candidate at S.No.6. As per my memory, the candidate has to submit copy of appointment letters from appropriate appointing authority for post(s) held by her in earlier institution before joining this University as these certificates have not been shown at the time of interview.

A foot note may be given as : Candidate at S.No.6 for the post of Associate professor in Electronics & Communication Engineering shall be asked to submit the copy of appointment letters from appropriate appointing authority for the post(s) held by her in earlier Institution(s).

Finally, it is my humble request kindly to make necessary arrangement for issuing corrigendum in the proceedings of 28th meeting of EC dated 20.09.2017 after considering all above mentioned facts. This will increase the sanctity, validity and sovereignty of our Executive Council of our University. With best regards,
