## Proceedings of the 30<sup>th</sup> Meeting (By circulation through e-mail) of the Executive Council of Tripura University, dated 15<sup>th</sup> June, 2018

The Joint Secretary (CU), Department of Higher Education, Government of India, Ministry of Human Resource Development, New Delhi contacted the Hon'ble Vice-Chancellor of Tripura University over phone in connection with the Tri-Partite MoU between Tripura University, MHRD and UGC. He requested to send the MoU urgently within next three (3) days, failing which, he informed that further funds would not be released to the University for the second quarter of the Financial Year 2018-19. He also mentioned that the MoU must be approved by the Executive Council. The Vice-Chancellor replied that as summer vacation in Tripura University has started from 11<sup>th</sup> June, 2018 and most of the members are on vacation, so quorum in an emergency EC meeting called in June, 2018 will be impossible to attain till the vacation is over. In response, the Joint Secretary, MHRD advised to arrange a meeting of the Executive Council through circulation.

Since the matter was urgent and approval of the Executive Council was necessary, therefore, the matter has been placed before the members of the council (by circulation).
