To report action taken by the Vice-Chancellor on enhancement of monthly wages/remuneration to contractual employees (Teaching & Non-Teaching).

**Resolution:** Action of the Vice Chancellor on enhancement of monthly Wages/Remuneration/Salary of contractual teachers were considered after clarification given by the Vice-chancellor. However, it was resolved that enhancement of Salary for Contractual Teachers be regulated strictly as per the UGC Regulations 2018/Govt. of India for those teachers only who were appointed against vacant sanctioned teaching posts. This should be allowed only for specific period and all vacant posts should be filled up on regular basis.

Actions of the Vice Chancellor on enhancement of monthly Wages/Remuneration/Salary of contractual Non-teaching employees (System Analyst) were not agreed and considered. The University is requested to review and discontinue the payment. It is also reiterated that appointment of contractual non-teaching employees should be made only against the sanctioned vacant posts for a specific period following established Rules. Further, it was also resolved that all vacant posts should be filled up on regular basis. For appointment of OSD on contractual basis was not recommended.
