Minutes of the 42nd Meeting of Executive Council, Tripura University, held on 4th September, 2024 (through Circulation of File).

Shri D.K. Himanshu, Under Secretary to the Government of India, Ministry of Higher Education, Department of Higher Education, New Delhi has sent a letter (vide F.No.20-9/2024-CU.IV dt. 20.08.2024) to all Vice-Chancellors of Central Universities for inclusion of representative of Ministry of Education in the Executive Council of Central Universities.

To ensure uniformity in governance across all central universities, it is suggested that the Secretary (Higher Education), Ministry of Education, Government of India or his/her nominee be included as a member of the Executive Council of Tripura University. It is further requested to take necessary steps to amend the Statutes of the University for inclusion of the above representative from the Ministry as a Member of the Executive Council.

The Section 30 of the Tripura University Act, 2006 stipulates:

"(2) The Executive Council may, from time to time, make new or additional Statutes or may amend or repeal the Statutes referred to in sub-section (1):

Provided that the Executive Council shall not make, amend or repeal any Statutes affecting the status, powers or constitution of any authority of the University until such authority has been given an opportunity of expressing an opinion in writing on the proposed changes, and any opinion so expressed shall be considered by the Executive Council."

Since the matter was urgent, a meeting through circulation of file has been arranged on 4th September, 2024 for seeking comments/views from the following members of the Executive Council:
