As directed by the Deputy Secretary, Department of Higher Education, Government of India, Ministry of Human Resource Development, New Delhi in his letter (via e-mail) on 13th May, 2020 and subsequently by the UGC, New Delhi on 18th June, 2020, the MoU (Tri-Partite) had to be sent to the Ministry urgently after the approval at the Governing Body level, i.e. Executive Council of the University, for release of funds for the year 2020-21.
