


Ms. Mitra provided an overview of the U.S. exchange programs sponsored by the U.S. Department of State, particularly by the Bureau of Educational and Cultural Affairs (ECA). She highlighted the opportunities these programs offer in fostering academic, cultural, sports, and professional exchanges, which help participants gain knowledge of foreign cultures and strengthen international relationships. She also elaborated on academic exchanges, the Community College Initiative Program, professional internships, service learning, and community-organized activities, covering a wide range of fields of study.


Additionally, Ms. Jayta presented insights into citizen exchanges, including the Everest International Model United Nations and OneBeat, a program that unites emerging music leaders globally to collaborate on original works and create a civically engaged network of musicians. She noted that applications for these programs typically open between August and September. Other programs discussed included the International Writing Program and sports diplomacy initiatives.
