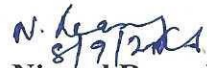

NOTIFICATION

This is for information of all concerned that students enrolled in the Integrated Master Degree (IMD) Programme under the National Education Policy (NEP) 2020 are eligible to submit their intent for Exit from the programme after completion of the 3rd or 4th year and obtain a Bachelor's Degree/ Post Graduate Diploma, as per the IMD-NEP Rules and Regulations of Tripura University, subject to fulfilment of the following conditions:

1. A student who has successfully cleared all papers from the 1st to 6th Semester and fulfilled the minimum requirement of 120 credits, and successfully completed the Internship/ Dissertation Course carrying 4 credits, shall be eligible to apply for Exit. Such students who have opted to Exit shall be awarded a Bachelor of Arts with Major (Major Subject)/ Bachelor of Science with Major (Major Subject)/ Bachelor of Commerce with Major as applicable.
 2.
 - a. A student who has successfully cleared all papers from the 1st to 8th Semester and fulfilled the minimum credit requirements and successfully completed the Internship/ Dissertation Course carrying 4 credits, shall be eligible to opt for Exit, such students who have opted to Exit shall be awarded Bachelor of Arts with Honours (Major Subject)/ Bachelor of Science with Honours (Major Subject)/ Bachelor Commerce with Honours.
- OR
- b. PG Diploma in Arts (Major Subject)/ PG Diploma in Science (Major Subject)/ PG Diploma in Commerce; as per decision of the BPGS of respective departments and approved by the Academic Council, TU.
 3. Applications for the Exit option shall be submitted through the Samarth Portal after publication of the 6th Semester/ 8th Semester results and within the stipulated period to be notified from time to time, subject to fulfilment of all eligibility criteria mentioned above.
 4. Students Opting for Exit may also apply for Provisional Certificate on payment of the prescribed fee along with a copy of last marksheet/ grade card and copy/ screenshot of the acknowledgement/ Reference No./ Exit Status from SAMARTH portal and required endorsements/ forwarding from the respective Departments/ Coordinators subject to fulfilment of the eligibility criteria specified in Clause 1/ 2/ 3 above.
